Dear Members,

Mass-ALA understands that securing PPE supplies continues to be a priority. You are still able to request PPE from the State ([click here](#) for directions). However, The State's PPE supply system is transitioning the process to request PPE supplies to more of an emergency framework. The process they would like you to follow is to request PPE supplies through established vendors. Once requests have been submitted through the ordinary supply chain, a community must provide documentation to the State that shows that you are seeking supplies from established vendors, but your needs have not yet been met. You will need to provide documentation to the State that your need is emergent and not being met by the first line of providers. The health and medical coordinator will get back to you regarding emergency or bridge needs.

PRIVATE COVID-19 TESTING SITES

The Massachusetts National Guard concluded testing in nursing homes, assisted living residences and rest homes on June 15. Do you need a test to determine if you may have COVID-19? The testing sites listed [here](#) are available by appointment only.

If you believe you may need a test, first contact your health care provider. If he or she recommends that you should be tested, but their facility cannot offer the test, obtain a referral and contact one of the facilities listed below. You may need to undergo an additional eligibility screen before you can be tested.

If you have a clinician's referral, contact one of the sites below to make an appointment. These sites do NOT take walk-ins and require an appointment.
